

People are becoming more concerned about single-use plastics...




Top 3 items for those who will reduce use

nowadays less often or never;




FIGURE 9: Overall PET Mass Balance, 2018

# Good for environment, people and business

### 96% respondents



Would like the introduction of a deposit system to decrease the amount of cans and PET bottles in nature by 95%

### 90% respondents



Would like the introduction of a deposit system to reduce carbon dioxide emissions by 39,200 tons

### 93% respondents

15,200 more tons of PET bottles and almost
 5,300 more tons of cans would be recycled than today
