Public support for deposit return systems

February 2024



Introduction

By the close of 2024, a total of 59 deposit return systems (DRS) – covering over 473 million people - will be operational worldwide for the collection and recycling of single-use drinks containers.

This number incorporates recent implementations in Romania (November 2023), Victoria (November 2023), Hungary (January 2024), and the Republic of Ireland (February 2024), as well as Tasmania (Australia), Goa (India), and Uruguay, all of which are expected to have systems in place by year-end. Looking ahead, DRS is also set to be implemented in Austria, Poland, and Singapore by the end of 2025. Turkey (home to 83 million people) is also gearing up for the launch of a nationwide system (set for 2025), commencing with pilot projects in 2024, initially focusing on major urban centres like Istanbul.¹

As the momentum for DRS gains traction, recent developments in Europe signal that even more deposit systems will be coming to the forefront in the next few years. In January 2024, the European Union (EU) entered into the final set of meetings (the 'trilogues') aimed at reaching a consensus on the Packaging and Packaging Waste Regulation (PPWR) proposal. The 'trilogues' are expected to be finalised by April.² Under these prospective new rules, member states would be mandated to set up a DRS to ensure the separate collection of at least 90% annually of single-use plastic bottles and metal beverage cans by 2029.³

Fortunately, there is a strong wave of public support for deposit systems, providing a gratifying assurance for governments currently contemplating DRS legislation as a strategy to meet recycling targets. This widespread support is substantiated by various public opinion polls, including a recent (2023) poll in France, where an impressive 92% of the population expressed support for the introduction of a deposit system. Similar support was echoed in a 2023 Scottish poll, with 72% of respondents backing UK-wide legislation for a DRS, and 70% supporting a Scottish DRS.

What's particularly noteworthy is that support isn't limited to new systems but extends to the appreciation of existing ones. In New South Wales (Australia), where a deposit system was implemented in 2017, a 2022 poll indicated that a remarkable 89% of respondents supported the scheme. This reflects a significant increase from the 78% support recorded in 2018, merely one year after the system's adoption, highlighting the growing endorsement and acceptance of deposit systems over time. Similarly, in Vermont (U.S.), a 2021 poll showed robust backing for the deposit system, with 88% of respondents expressing their support.

Also compelling are the opinion polls that reveal support for the expansion of existing systems, which indicate enthusiasm for increasing the deposit level or adding new types of containers and/or beverages. For instance, in Western Australia, which introduced a DRS in 2020, a 2022 poll revealed that 93% of residents supported expanding the system to include even more types of containers. Similar polls conducted in New York (US) and Ontario (Canada) demonstrated strong support for the expansion of deposit legislation, with 71% and 76%, respectively, endorsing the inclusion of a wider array of beverage containers.

Beverage and packaging industry support

Amidst this groundswell of public support, there is also a notable uptick in industry backing for DRS.

In October 2023, soft drink giants, including Coca-Cola and PepsiCo wrote an open letter to UK Prime Minister Rishi Sunak urging him not to scrap the UK's planned DRS. In their letter, the drinks industry stated: *"if drinks manufacturers and retailers are to reach net zero, they will need to reduce the carbon footprint of their packaging – the most effective way of achieving this is through the introduction of a deposit return scheme."⁴*



In the U.S., the Can Manufacturers Institute (CMI)'s Senior Vice President of Sustainability stated publicly that it cannot achieve its recycling rate target of 70% by 2030 without new, well-designed deposit programmes.⁵ Together with the Aluminum Association it is currently working with like-minded organisations to educate policymakers on the benefits of DRS and to advance legislation that would establish a well-designed system.⁶



In November 2023, Natural Mineral Waters Europe (NWME) and UNESDA Soft Drinks Europe issued a joint statement, acknowledging "welldesigned DRS as the proven most effective pathway to high rates of separate collection for recycling."⁷ In their letter, they acknowledge that "countries with DRS have much higher performance rates of collection and recycling, most surpassing mandatory EU targets."⁸



In Australia, Lion, Coca-Cola Europacific Partners and Asahi Beverages – all members of the not-for-profit organisation VicReturn, the Scheme Coordinator for Victoria's DRS – have issued statements welcoming the new scheme, launched in November 2023. Vice President and General Manager -Australia, Pacific & Indonesia, Coca-Cola Europacific Partners Peter West stated that "the launch of CDS Vic represents" a step-change for Victoria's circular economy" and that they are "proud to help create a closed loop in Victoria where bottles and cans can be used. collected, recycled, and reborn."9

About this fact sheet

This fact sheet compiles findings from over 180 public opinion polls spanning the last two decades (2003-2023).

The data delves into public attitudes and opinions towards deposit return legislation in 29 jurisdictions including Australia, Austria, Belgium, Bulgaria, Canada, Czech Republic, Denmark, England, France, Germany, Hungary, Republic of Ireland, Italy, Latvia, Lithuania, the Netherlands, Northern Ireland, New Zealand, Poland, Portugal, the Republic of the Maldives, Romania, Scotland, Singapore, Slovakia, Spain, the United States (US), the United Kingdom (UK), and Wales.

Table 1 summarises the total number of opinion polls carried out globally from 2003-2023, highlighting the number of polls assessing support for the introduction of new systems, existing legislation, and the expansion of DRS (for a more comprehensive exploration of the individual opinion polls discussed in this fact sheet, Appendix A provides a detailed breakdown of essential information. This includes – where available – specifics on the organisations conducting the studies, the survey methodologies employed, sample sizes, and the date ranges during which the polls were conducted.). The table also includes the median level of support for each aspect of deposit legislation, encompassing all available data points.

It's worth noting that the table does include instances where some polls are represented twice. This arises, for example, if respondents are asked for their support of two different things, like their support for the deposit level or the types of containers included in the system. For instance, a 2022 lowa poll found that 46.1% of respondents were in favour of expanding the legislation to include more types of containers and 33.5% were in favour of increasing the deposit (taken together, 51.0% supported increasing at least one component). In this specific case, the poll is reflected twice in the table: once under 'expansion' and once under 'existing.'

Another example of where one poll is counted twice in the table is if it looks at level of public support for DRS in different jurisdictions. For example, an October 2013 poll for the Boomerang Alliance examined the public's level of support for DRS in various Australian states (e.g., Western Australia, Victoria, Tasmania, etc.). Similarly, a 2023 poll carried out in Scotland asked respondents' for their level of support for introducing a DRS in Scotland as well as their level of support for a UK-wide system. In such instances, each state or country is treated as an independent opinion poll, contributing its distinct data point in the table.

When interpreting the data, it's also important to consider that the level of detail covered by various polls can vary. Take, for example, the 2023 survey conducted by Toluna Harris Interactive in France. This particular survey went beyond general support for DRS and asked respondents about their specific support for deposits on glass, plastic bottles, cans, and aseptic containers (e.g., Tetra Briks). Additionally, the poll delved into the nuances of support by inquiring about respondents' preferences for introducing deposits on different combinations of container types—whether on only one type, two types, three types, or all four types.

A 2022 survey conducted by Ipsos offers a similar example; instead of asking respondents' for their overall level of support for introducing a DRS in the Czech Republic, it asked people whether they were in favour of introducing a deposit system for plastic bottles and also on cans.

Another poll carried out in 2008 to gauge support for a DRS in the UK asked respondents whether they'd support a scheme with a 5p deposit versus a 10p deposit. Despite generating multiple data points, polls such as these are treated as a single entry in the table (but as separate entries in the bar charts). This decision is made because all the questions within the survey focus on gauging support for the introduction of DRS.

The accompanying series of bar charts provides a succinct visual overview of findings from diverse regions, including Europe, the United States, Canada, and Oceania. Each region-specific chart is structured to illustrate support for distinct aspects of deposit legislation: the introduction of new systems, the expansion of existing legislation, and backing for existing systems.

It's important to note that in certain jurisdictions, multiple opinion polls have been conducted over time. To enhance clarity and focus, the bar charts showcase the most recent poll results only, presenting a current and relevant snapshot of public attitudes towards DRS in these regions.

In certain cases (e.g., Scotland, France, Romania), multiple polls were carried out in the same year by different organisations. Interestingly, varying results emerge from these different polls; for instance, in France, one poll reported 92% support for DRS introduction, another found 83% support, and yet another recorded 75%. These disparities might be attributed to various factors, including differences in sample size, demographic composition, and the age groups surveyed. Additionally, variations in guestion wording (as mentioned earlier) and how DRS is framed within the overall guestion contribute to the observed differences. For instance, one poll might inquire about support for DRS as an effective tool to reduce litter, framing it positively. In contrast, another poll might present DRS differently, such as asking respondents if they endorse paying an additional fee for beverage containers, which is returned to them upon recycling. Although both of these questions address support for deposits, their distinct framing can elicit diverse responses. Notwithstanding these disparities, it's clear that a steadfast current of enthusiastic support for DRS remains, underscoring its widespread popularity across a spectrum of demographics and contexts.




Figure 1: Public support for deposit return legislation in Europe





Figure 2: Public support for deposit return legislation in the U.S.

Figure 3: Public support for deposit return legislation in Canada






Figure 4: Public support for deposit return legislation in Oceania
